1. INNOPROM-2011. Summary



12-15 JULY EKATERINBURG-EXPO

THE URAL

During July 14-17, 2011, Ekaterinburg hosted the second Urals International Industrial and Innovation Exhibition and Forum INNOPROM-2011. One distinctive feature of INNOPROM-2011 was the record breaking area of the event -60,000 sq.m in the new Exhibition Center Ekaterinburg-Expo. Over 400 Russian and foreign companies from 30 countries participated in INNOPROM-2011. During four working days of INNOPROM, it was visited by about 50,000 people. 8,500 staff members of the federal and regional authorities were involved in discussion groups of the Forum.

During four working days of the Exhibition and the Forum:

- over 80 business events were held: conferences, round table discussions, discussion groups, meetings, presentations and master classes
- contracts were signed amounting totally to around RUR 180 billion, which is comparable with the annual consolidated budget of Sverdlovsk Region
- 39 agreement were concluded, of which 10 were signed personally by Alexander Misharin, Governor of Sverdlovsk Region.


GENERAL INFORMATION



According to the Order of the Government of the Russian Federation No.415-p dated March 16, 2011, the Urals International Industrial and Innovation Exhibition and Forum INNOPROM-2012 will be held in Ekaterinburg during July 12-15, 2012.



Participation in the Exhibition with customized facilities.

Unfurnished exhibition areas of minimum **20 sq.m** are provided to the Exhibitor for the whole period of the Exhibition. Installation of an exhibition stand in these areas is carried out either by the Exhibitor itself, or by outside construction companies (accreditation of outside construction companies is mandatory).

The cost of **1 sq.m** of unfurnished exhibition area in the pavilion is **RUR 5,500** (including VAT) + surcharge for better viewing

Mandatory registration fee is RUR 10,000 (including VAT).

Placement of company information on the web-site and in the paper catalogue of the Exhibition and the Forum









Participation in the Exhibition with customized facilities in the improved viewing area.

Unfurnished exhibition areas of minimum 50 sq.m are provided to the Exhibitor for the whole period of the Exhibition. Installation of an exhibition stand in these areas is carried out either by the Exhibitor itself, or by outside construction companies (accreditation of outside construction companies is mandatory).

The cost of **1 sq.m** of unfurnished exhibition area with improved viewing is RUR **11,000** (including VAT) Mandatory registration fee is RUR **10,000** (including VAT).

Placement of company information on the web-site and in the paper catalogue of the Exhibition and the Forum.











Participation in the Exhibition with large-sized machinery in the pavilion


Unfurnished exhibition areas of minimum 50 sq.m are provided to the Exhibitor for the whole period of the Exhibition. The cost of **1 sq.m** of unfurnished exhibition area in the pavilion is RUR 2,500 (including VAT). Mandatory registration fee is RUR 10,000 (including VAT).


Participation in the Exhibition with large-sized machinery in the outdoor area

Unfurnished exhibition areas of minimum 50 sq.m in the outdoor area are provided to the Exhibitor for the whole period of the Exhibition. The cost of 1 sq.m of unfurnished exhibition area in the outdoor area is RUR 1,000 (including VAT).

Mandatory registration fee is RUR 10,000 (including VAT).







Participation in the Exhibition in the furnished exhibition area

An exhibition stand with total area of minimum **9 sq.m** is provided to the Exhibitor for the whole period of the Exhibition. The cost of 1 sq.m of the furnished exhibition area is RUR 6,500 (including VAT) + surcharge for better viewing.

Mandatory registration fee is RUR 10,000 (including VAT).




